Note: for any “Yes” answer, follow up questions will include, but not limited to: type, last time, first time, number of times/frequency, explanation, etc

### **Biographical Data**

- Marital status
- Previous marriages?
- Do you have any children?
- Are you proficient in any language other than English?
- What’s your current email address?
- Any additional email addresses?
- What social media sites do you have accounts with?
- Do you own any websites?
- Are you currently listed on any websites?
- Best phone number to reach you?
- Do you go by any other names?
- Have you ever performed court-mandated community service?
- Have you ever been on court-mandated probation?
- Have you ever paid a fine for anything beyond a traffic-related infraction?

### **Education**

- What’s the highest education you have earned?
- Have you ever been expelled or suspended from elementary school, middle school, high school, college, or university?

### **Tenancy**

- Have you ever been evicted?
- Have you had any issues with present or previous landlords?
- Are you currently late paying the rent or mortgage?

### **Financial**

- Have you ever been foreclosed upon?
- Have you ever filed for bankruptcy?
- Have you ever received any civil judgments or being sued?
- Have you ever had anything repossessed?
- How much are you in debt?
- Are you currently behind in providing child support?
- Are you currently behind on any bills?
- Do you have any debts that are refusing to pay?

### **Employment**

- Current employment:
- Have you ever served in the military?
- Have you had any experience as a law enforcement officer?
- Current applications with law enforcement agencies?
- Have you ever attended a law enforcement academy?
- Have you ever been fired from any places of employment?
- Have you ever been forced to resign from any places of employment?
- Did you ever quit any place of employment in order to avoid being fired?
- Have you ever received any written reprimands at any places of employment?
- Have you ever been suspended at any places of employment?
- Have you ever been demoted for disciplinary reasons at any places of employment?

- Have you ever been reassigned at work as a result of, or in lieu of, being disciplined?
- Have you called in sick to work in the past twelve months without legitimately being sick?
- Did you ever quit a place of employment without giving proper notice?
- Have you withheld any place of employment?
- Have you had any professional license(s) suspended or revoked?
- Do you have any intentions of leaving this job in the near future, if hired?
- Have you been under any internal investigations (Command, Professional Standards, EEO, personnel investigations?)

### **Illegal Gambling**

- Have you ever been involved in illegal gambling (animal fights, street fights, street racing, etc)?

### **Use of Alcohol**

- How much alcohol do you consume per day/week/month?
- Have you been intoxicated in the past five years to the point of being sick or hung over?
- Have you ever consumed alcohol while at work without authorization (during work hours), including at lunch and while on breaks?
- Have you ever become intoxicated while at work?
- Have you ever come to work while under the influence of alcohol?
- Have you ever missed work or arrived late due to your consumption of alcohol?
- Have you ever operated a motor vehicle while under the influence of alcohol?
- Did you drink alcohol while under age?
- Have you provided any alcohol to minors, since you became an adult?
- Have you ever been cited for having an open container?

### **Illegal Drug Use**

- Have you ever used illegal drugs (marijuana, cocaine, speed, meth, LSD, PCP, ecstasy, heroin, morphine, steroids, mushrooms, opium, amphetamines, steroids, etc)?
- Have you ever used synthetic drugs (K2, Spice, bath salts, etc.)?
- Have you ever used Salvia or any psychoactive plants to get high?
- Have you ever used any household or automotive products to get high?
- Have you ever used any prescription or over-the-counter medications to get high?
- Have you ever worked under the influence of illegal drugs?
- Have you ever used any illegal drugs while at work, including during lunch or breaks?
- Have you ever driven under the influence of any illegal drugs?
- When was the last time you were around someone while they were using any illegal drugs?
- Last time you were offered an illegal drug?

### **Other Drug Activity**

- Do you currently know anyone who sells drugs illegally?
- Do you currently know anyone who grows marijuana illegally?
- Have you ever purchase illegal drugs?
- Have you ever sold illegal drugs?
- Have you ever sold any prescription medications?
- Have you ever transported illegal drugs for profit?
- Have you ever delivered any illegal drugs for someone else?
- Have you ever directed others in the purchase or sale of any illegal drugs?
- Have you ever cultivated marijuana?

- Have you ever manufactured illegal drugs?
- Have you ever provided urine to someone else for use on a drug test?
- Have you ever used someone else's urine, diluted urine, or synthetic urine in order to pass a drug test?
- Have you ever used a masking agent before a drug test?
- Have you ever failed a drug test?
- Have you ever forged a prescription in order to obtain medication?
- Have you provided tobacco products to minors, since you became an adult?

### **Arrests and Detentions**

- Have you ever been arrested, including being expunged, sealed, dropped, or as a minor?
- Have you ever been detained for the investigation of a crime?
- Have you ever been fingerprinted for law enforcement reasons other than for employment?
- Have you ever been read Miranda rights?
- Were you ever charged with a violation of the Uniformed Code of Military Justice? (Captain's Mast, Office Hours, Court Martial, Article 15, etc.)
- Have you been the subject of any Law Enforcement investigation?

### **Notices**

- Have you ever received a No Trespass warning?
- Have you ever received a No Contact Order?
- Have you ever been issued a Restraining Order or an Order of Protection filed by someone else?

### **Driving History**

- Have you ever had a driver's license suspended?
- How many traffic citations in the past FIVE years?
- Have you been involved in any AT-FAULT motor vehicle accidents in the past FIVE years?
- Have you received any traffic warnings in the past 12 months?
- Did you ever drive away from the scene of an accident, without reporting it?
- Have you received any boat warnings or fines in the past 12 months?
- Have you ever been involved in illegal street racing?

### **Associations**

- Do you have any family members, relatives, or friends that have been convicted of a felony?
- Have you ever associated with gang members?
- Have you ever associated with members of subversive groups?
- Have you ever associated with members of organized crime?
- Have you ever been with people while they were committing any illegal acts?
- Have you ever visiting anyone in jail or prison?

### **Membership**

- Have you ever been a member of a gang?
- Have you ever been a member of a subversive group?
- Have you ever been a member of an organized crime organization?

### **Vandalism**

- Have you committed any vandalism?

- Have you damaged anyone else's property to cause damage or harm?
- Have you ever set fire to cause damage or harm?
- Have you ever exploded anything to cause damage or harm?
- Have you ever intentionally spread a computer virus?

### **Theft**

- Have you ever broken into a coin operated device in order to take merchandise or money?
- Have you ever purchased a stolen credit card or check?
- Have you ever taken anything from a store without paying for it?
- Have you ever changed price tags on items at a store?
- Have you ever downloaded or copied music, movies, or software illegally for profit?
- Have you ever stolen any car parts?
- Have you ever stolen anything from a family member, relative, friend, or stranger (prisoner, custody, etc.)?
- Have you ever stolen anything from a place where you have either volunteered at or attended school?
- Have you ever stolen money from a place of employment?
- Have you ever stolen property or equipment from a place of employment (lost and found, evidence room, etc.)?
- Have you ever stolen merchandise from a place of employment?
- Have you ever stolen supplies, food, or drinks in excess from places of employment?
- Have you ever intentionally not turned in equipment, tools, or uniforms back to work?
- Have you ever kept money from register overages?
- Have you ever used a company or agency gas card, credit card, or company or agency funds to pay for personal items?
- Have you ever given someone an unauthorized discount or free items at work?
- Have you ever knowingly purchased, sold, or possessed stolen property?
- Have you ever pawned stolen items?
- Have you ever stolen a car, truck, SUV, boat, plane, jet-ski, three-wheeler, or other vehicle?
- Have you ever stolen anything from a yard or construction site?
- Have you ever burglarized a house, store, church, school, or any other buildings?
- Have you ever burglarized a car, truck, SUV, boat, plane, or any other vehicle?

### **Fraud & Deceit**

- Have you ever hacked into anyone else's computer, email, server?
- Have you ever attempted to bribe anyone?
- Have you ever accepted a bribe?
- Have you ever lied on an employment application?
- Have you ever lied on a time card?
- Have you ever signed someone else's name without their permission, as an adult?
- Have you ever lied in order to receive public assistance, welfare, or unemployment?
- Have you ever filed a false, or an exaggerated insurance claim?
- Have you ever filed a false or exaggerated workman's compensation claim?
- Have you ever fraudulently filed false income on tax returns?
- Have you ever fraudulently claimed dependents on tax returns?
- Have you ever used someone else's credit card, debit card, ATM, or gift card without their permission?
- Have you ever cashed someone else's check without their permission?
- Have you ever used someone else's name or SSN?

- Have you ever used some else's social security card, birth certificate, passport, or other form of ID?
- Have you ever written a check that you were certain would not be covered by sufficient funds?
- Have you ever used a handicap sign illegally?
- Have you ever called in a false bomb threat, false fire threat, false criminal threat or false terror threat?
- Have you ever forged or altered any documents?
- Have you ever filed a false police report?
- Have you ever distributed or produced counterfeit money?
- Have you ever received electricity, water, cable, or satellite services without paying for it?
- Have you ever impersonated a law enforcement officer?
- Have you ever falsely accused someone officially of anything?
- Have you ever officially filed a false complaint?

### **Violence**

- Have you ever carried a concealed weapon illegally, or without a permit?
- Have you ever killed anyone, either accidentally or otherwise?
- Have you ever committing domestic violence?
- Have you ever been accused of domestic violence?
- Have you intentionally set animals on fire?
- Have you ever intentionally killed an animal outside of hunting?
- Have you been involved in any physical fights since high school?
  - If LE experience, ask: Have you used unnecessary / excessive use of force?
- Have you ever committed any hate crimes?
- Have you ever said any racial slurs directed at others?
- Have you ever been questioned as a suspect by a family protective services, child protective services, Health and Human Services, Department of Social Services, or Department of Children and Family Services?
- Have you ever stalked anyone?

### **Sex Crimes**

- Have you ever viewed pornography at work?
- Have you masturbated at work?
- Have you ever urinated in public where your private sexual parts could be seen by others?
- Have you provided any pornography to minors, since you became an adult?
- Have you ever paid for sex?
- Have you ever been paid for sex?
- Have you ever had sexual contact as an adult with anyone under age?
- Have you ever sent, received, produced, stored, viewed, or been in possession of child pornography for sexual reasons?
- Have you ever forced someone to participate in a sexual act?
- Have you ever had sexual contact with someone who was asleep or unconscious?
- Have you ever committed an act of voyeurism?
- Have you ever committed an act of exhibitionism?
- Have you ever solicited a minor for sex?
- Have you ever had sexual contact with animals?
- Have you ever had sexual contact with a dead person?
