## CAD Cleared Shelf Initiative <br> 06/15/2010-07/31/2010

## I. Introduction to the Big Picture

Between June15, 2010, and July 31, 2010, 305 exams were administered to "cleared shelf" applicants. Of those 305 exams, 12 were retests and 10 exams are pending a retest (unresolved). This equates to CAD completing polygraph exams on 283 applicants. In addition, there were 73 declinations ("No Tests"). When added to the 283 exams completed, this equates to a total of 356 cleared shelf applicants completely processed by CAD by July 31, 2010. Finally, CAD administered 35 other exams during this same period that were not listed as cleared shelf applicants.

## II. Exam Results

Depicted in the Illustration below are the exam results of the 283 cleared shelf applicants whose exams were completed by July 31, 2010. NOTE: "NO" = "No Opinion."

## III. Analysis of Admissions

In the illustration below, admissions are displayed for each of the four exam result categories. In addition to the number, there are two types of percentages listed. The first percentage listing is the percentage of the entire 283 exams and the second type is the percentage within that particular exam result category. For example, there were 77 admissions out of the 131 exams with NSR results. This equates to $27 \%$ of all 283 exams administered and $59 \%$ of the exams within the NSR result category. In addition, there were a total of 195 admissions across all exam result types, which equates to $69 \%$ of all exams administered. Finally, there were 81 exams with unsuitable-type admissions, which comprised $29 \%$ of all exams administered.

## IV. Inconclusive and No Opinion Exams

Of the nine exams that had a final result of Inconclusive (INC), eight had unsuitable admissions and one had a medical issue that prevented further testing. Of the 20 exams that had a final result of No Opinion (NO), 15 had either countermeasures, unsuitable admissions, or both. Of the five exams without admissions, three had countermeasures, one withdrew, and one had a medical issue.

## V. Pass / Fail Rate

124 applicants were NSR without unsuitable admissions (44\%). This is the category of applicants who "passed" (cleared by polygraph). 159 applicants "failed" (not cleared by polygraph). The "failed" category is comprised of a combination of SR results and/or unsuitable admissions/countermeasures.
