
**ORDER ON MOTION TO CONTINUE TRIAL**

THIS MATTER came before the Court for hearing on Joint Motion to Continue Trial. After review and consideration, it is ORDERED AND ADJUDGED as follows:

1. The Motion to Continue Trial is GRANTED
2. This matter is reset for non-jury trial on the 6-week calendar **BEGINNING August 9, 2021 AND ENDING September 17, 2021. E-CALENDAR CALL IS DUE July 30, 2021 by end of business day.** All counsel and *pro se* parties are directed to fully complete the E-Calendar Call Information Sheet attached to this Order as Exhibit "A". Only **one** form per case is required. The E-Calendar information sheet must be e-mailed to the Divisional e-mail: [CAD-DivisionAE@pbcgov.org](mailto:CAD-DivisionAE@pbcgov.org) no later than **July 30, 2021**. Any party requesting a continuance of trial is to file a motion and set the matter for hearing on the court's UMC calendar online.
3. As this case has previously been set on a trial calendar, the parties are directed to comply with the pretrial procedures set forth in the original order setting trial. The parties are directed to confer to set new deadlines to comply with the Court's pretrial procedures in light of the new trial setting. If the parties are unable to agree on reasonable deadlines, they shall schedule a UMC hearing on the matter to be heard within 45 days and the Court will set new deadlines. Noncompliance with any portion of this order, or the previously

entered order setting trial, may result in the striking of the case, witnesses, or exhibits, or imposition of such other sanctions as are just. **DISCOVERY, MOTION PRACTICE, AND MEDIATION MUST BE CONCLUDED AND PRETRIAL STIPULATION FILED 10 DAYS PRIOR TO CALENDAR CALL.**
