Parties may appear remotely through ZOOM.

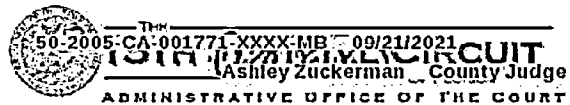
