

I'm not thrilled with his views of polygraphs but he is not used to working with them so I'm hoping you can show him that the views he has are false and very outdated. We do have a contract with him that I feel we will need to honor until it is up (can't remember if it was a 1 or 2 year contract) so if we can try to clue him in on what really happens I think that is a better idea than bringing in a new therapist. We only have 1 sex offender therapist willing to come to Parker so we are really strapped when it comes to choices. Today, in speaking with this provider he said some things that have me worried about our "team". He is not a fan of polygraphs and believes polygraphers have an "agenda" and that you ask questions that aren't discussed first, etc. Although he knows that we use them in probation and does not tell the offenders to not take them or not cooperate with them, he does share his beliefs with the offenders. I told him that his "attitudes" about certain things will spill over into how they perform on probation because they will feel that his "a knows how stupid it is...he will agree with me...etc." I advised how important it is that we are 1 big cohesive team and that for all intents and purposes...it is not leading group...it is Probation leading group in the form of

He further believes that sexual histories are not a good tool because they ask all kinds of stupid questions that don't relate to actual sex offenses...such as "have you ever taken a naked picture of yourself?" or "Have you ever had sex in a public place?" I tried to point out that it's a way for the

offender to really search his mind and maybe remember things that he might not otherwise, but by thinking about the "taking of a naked picture" it jogged his memory of when he sent a naked photo to an underage kid or something...he didn't agree. He also firmly believes that if they have to take the sexual history polygraph...it should be done prior to the instant offense poly (if they deny the offense). I even gave him the handout from Ben Galarneau who just presented at the sex offender training that you did last year for AOC....he still thinks he's right and everyone else is wrong.

I told him I would be giving you his email address and phone number because I am hoping that you two can connect on some level and maybe you can assuage him of all his fears and distrusts of polygraphs. Hi Kelly,

The sexual history packet should be distributed and reviewed with the client by the treatment provider. The sex history and instant offense tests are both primarily for treatment to break denial. If a client fully admits to the details of his instant offense, then he can be progressed into a sex history test without doing an instant offense test. If the client denies his instant offense, then we need to do an instant offense test before we move to a sex history. What I recommend, is making sure we have a maintenance test at least once a year (preferably every 6 months) and then fitting the treatment tests somewhere in between without going over a year without a maintenance test. would be fine to do an instant on if they are denying their offense and if they are in treatment. There is not much sense running an instant offense if they are not in treatment. At some point, eeds to admit to his instant offense. I know that West Winds will discharge them from treatment if they don't eventually fess up, but that is up to the treatment provider on how they handle it. The next test for hould be a maintenance.
